#### HOT LUNCH

#### STUDENT ACTIVITIES

Urban Village Academy includes all student activities in our tuition fee. This portion of tuition is used to cover costs for all school initiatives such as: materials, textbooks, activities, clubs, athletic events, student council, awards, guest speakers and more.

### TERMS AND CONDITIONS

**Application Fee:** Each new student must pay a one-time administrative/application fee of \$250. This fee does not guarantee enrolment or placement on a waitlist. If registered, this fee will be credited to the student's last tuition payment.

**Payment of fees:** All parents/guardians are responsible to pay Urban Village Academy, a division of Bulldog KIDS, the fees for the full academic year. Payments can be made by cheque(s) or pre-authorized debit. In the event of default in the payment of any instalment provided for in this contract, a student may not be allowed to continue classes and parents/guardians will be responsible for all legal fees and reasonable costs of collection for any outstanding amounts due under this contract.

**Withdrawal:** Any notice of withdrawal must be made in writing. The Application Fee is not-refundable in the event of withdrawal before the end of the academic year, with no exceptions. If a parent/guardian wishes to withdraw a student after enrolling, the following conditions apply;

- Withdrawal prior to April 30th, 2021: Any post-dated payments will be cancelled or returned. The application fee will not be refunded.
- Withdrawal on or after May 1st, 2021: 100% of total balance of tuition fees are due/owing unconditionally, regardless of payment option. The application fee will not be refunded.

**Late Payment and NSF Fees:** All late payments are subject to 1% interest per month (12% per annum). There is a \$50 fee applied to any NSF pre-authorized debit payments or cheques.

**Yearly Statements:** Yearly statements (calendar year) are provided via e-mail and parent communication app in February.
